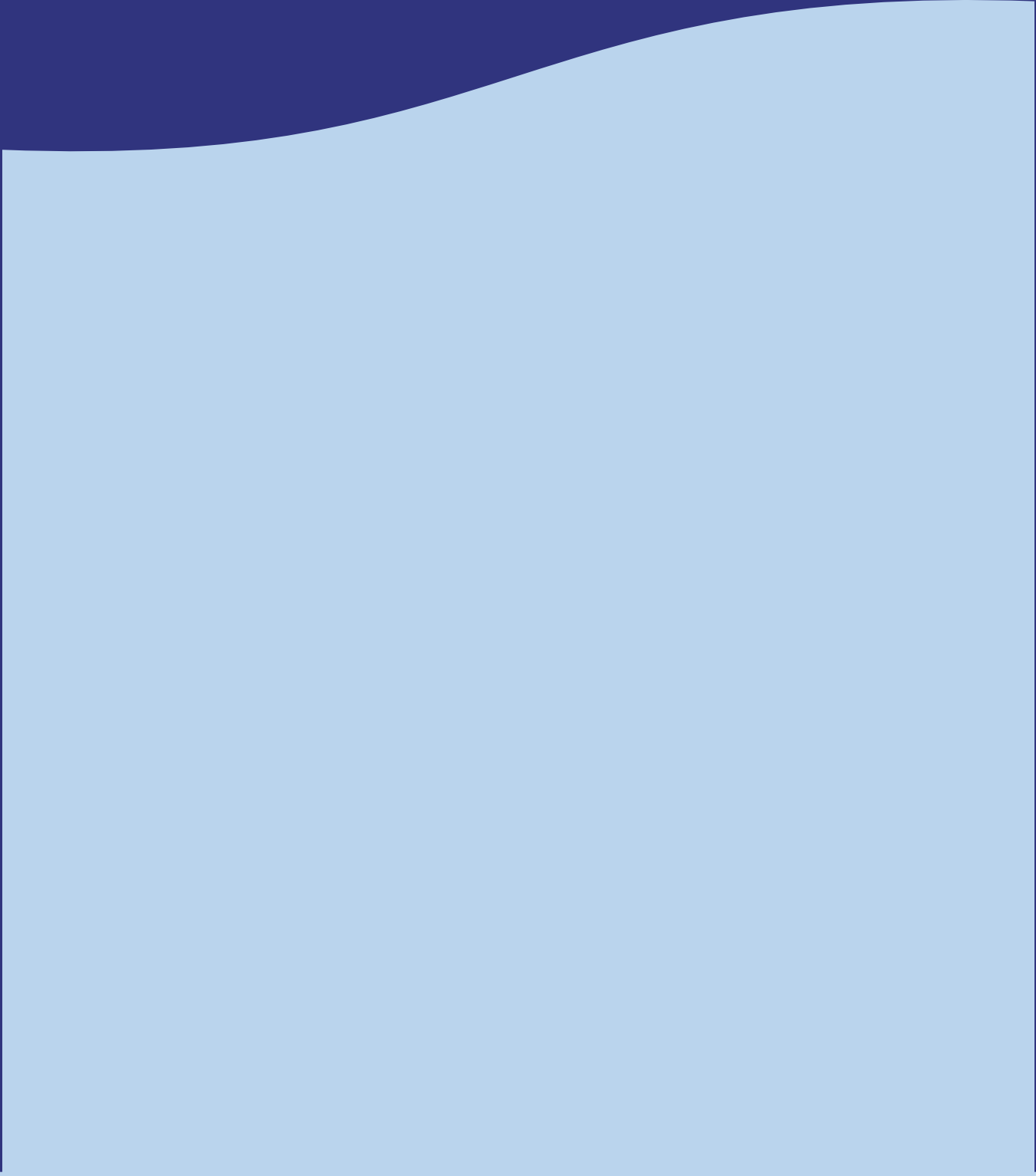

Fish Market Place is committed to supporting the Ebor community and the local economy. We are proud to be a part of the Ebor community and to support the local economy.

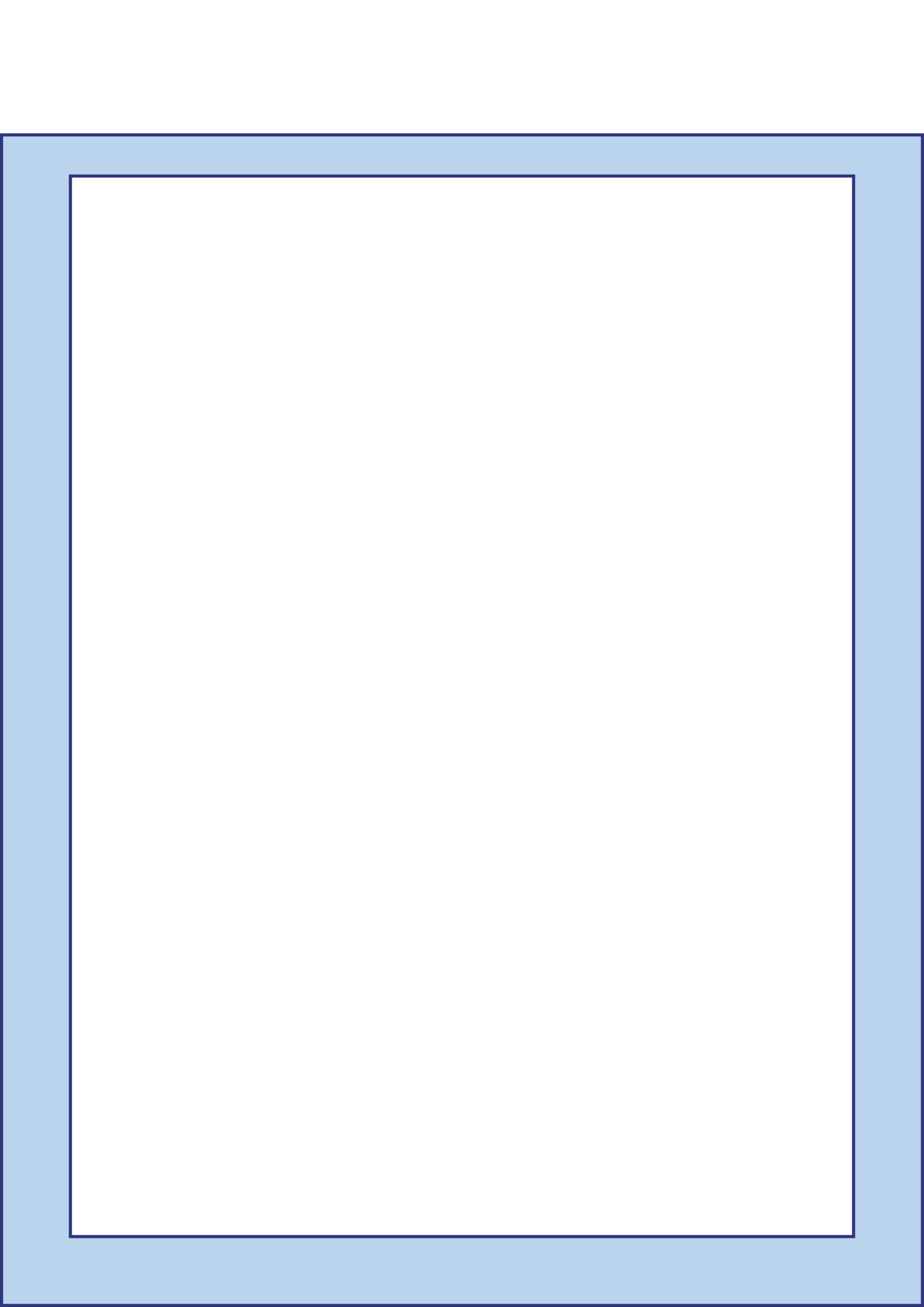
